1. You may be required to provide documentation (such as a driver's licence, passport or Medicare card) to prove your identity and age, as part of this application.
2. If you do not renew your Exceptional Circumstances Additional Waste collection service you acknowledge you are no longer entitled to the additional waste service and that the bin must be returned to Fleurieu Regional Waste Authority.
3. Additional bins granted under Exceptional Circumstances are required to display an 'exempt' sticker in the appropriate colour for the current financial year.
4. This is a renewal only and any change of circumstances need to be submitted in person to the Kangaroo Island Council.
5. Only the person listed in Section A is authorised to sign below. If the person listed in Section A is no longer the applicant a new application needs to be submitted in person to the Kangaroo Island Council.
6. Applications for this service are required to be submitted annually.
7. The Fleurieu Regional Waste Authority may conduct audits on Exceptional Circumstance bin recipients.
