





Council has a borad range of statutory functions, powers and duties. Many Regulatory functions of council are undertaken by persons appointed as authorised persons pursuant to legislation. A person appointed as an authorised person/officer under legislation has the functions and powers which the legislation prescribes in relations to that appointment.

This is the Register of Authorised Officers appointed by the Chief Executive Officer under delegations from the Council. This document does not operate as an instrument of appointment and each officer appointed by the CEO has a separate instrument of appointment and identity card.
