NOTICE UNDER SECTION 33 ROAD TRAFFIC ACT, 1961

I, Christopher Drew Holland, Senior Sergeant of Police, for, and on behalf of the Commissioner of Police, exercise the authority delegated by the Minister for Transport under Section 11 Road Traffic Act, and make the following order under Section 33 of the Act.

I declare that the '**1/4 Mile Sprint Event**' is an event to which this section applies and that the following road be closed to traffic **on Sunday 10 March 2024, between 7.00 am and 5.00 pm.**

Within the Kangaroo Island Council area: -

- **Arronmore Road, Cygnet River** between Angle Pole Road and Hog Bay Road.

I direct that competitors and officials taking part in the '**1/4 Mile Sprint Event**' be exempted, in relation to a road on which the event is to be held, from the duty to observe any enactment, regulation or by-law prescribing a rule to be observed on roads by drivers of vehicles.

I further direct that the event must comply with the following:

- Comply with all Motorsport Australia requirements under permit **ARR C 24**
- All vehicles participating must be registered and road worthy and are not exempt by this notice
- All participants must hold appropriate drivers licence and not be disqualified from driving or from holding a licence in any state or territory as not exempt by this notice.
- Participants are not exempt from RTA offences related to drink and drug driving as not exempt by this notice.

I also hereby authorise **Kangaroo Island Council** or its agents and contractors to install and remove, or cause the installation and removal of necessary and appropriate traffic control devices for the conduct of this event.

TEMPORARY TRAFFIC CONTROL DEVICE NOTICE UNDER SECTION 17 (3) ROAD TRAFFIC ACT, 1961

I further declare that the '**1/4 Mile Sprint Event**' to be conducted at **Kangaroo Island** is a '**temporary purpose**' to which this section applies.

I direct that a **40 km/h** speed restriction will apply to the following roads **on Sunday 10 March 2024, between 7.00 am and 5.00 pm:**

Within the Kangaroo Island Council area: -

- **Angle Pole Road, Cygnet River** between Arronmore Road and a point approximately 100 metres northeast

- **Arronmore Road, Cygnet River** between Angle Pole Road and a point approximately 100 metres northwest

I direct that the installation and removal of necessary and appropriate traffic control devices for the conduct of this event can only be performed by a person with work zone traffic management training.

All works to be undertaken must be done so in accordance with the **"SA Standards for Workzone Traffic Management"** (which calls up the Austroads Guide to Temporary Traffic Management and AS1742.3).

The permit holder must ensure that, a legible and complete copy of this Approval (as either a hard copy or electronic copy) is available at the event site at all times that workers are present and is immediately provided to an Authorised Officer upon request.

The drivers and passengers of these vehicles undertake the event wholly at their own risk and shall release and indemnify the Police Commissioner for any liability for injury or damage whatsoever inclusive of injury or loss sustained by third parties.
