

## TOWN CENTRES PROJECT UPDATE

### KINGSCOTE - ROAD CLOSURE DAUNCEY STREET

Following consultation with individual business owners on Dauncey Street regarding the timing of the road closure to finalise works, Axiom have advised they will return to Kingscote on 7 November 2022. A one-week street closure will commence on 14 November 2022, with the street re-opened for two weeks and finally closed for two weeks before works are complete. The timing of the road closure was subject to the availability of Fulton Hogan to seal the road on 12 December. We thank the community for their patience. Please note the road will be closed for general traffic however it will be accessible to emergency services. Council will be speaking with traders regarding their business needs including deliveries. **Access to all businesses will remain during these works.**

Priority parking will be made available at the Murray Street and Commercial Street ends of Dauncey Street. There will be signage at either end advising that traders are open for business. Council will be working with traders to launch a "Go Local First" campaign to support local businesses in the lead up to Christmas. ## FIRE PREVENTION - 105F NOTICES

Private landholders are responsible under the *Fire and Emergency Services Act 2005* (the Act) for preparing their properties before the start of the Fire Danger Season.

Under the Act, if a property is not fire ready by **1 December 2022** for fire danger season, Council's Fire Prevention Officers will serve a 105F notice accompanied by a fine of **\$473**.

Landholders then have 21 days to complete the required works after receiving a 105F notice. If after 21 days the required works have not been done, Council will engage a contractor to complete the necessary works with the **cost applied to the property owner and charged against the land**.
