REDBANKS ROAD



Following negotiations, the Council received a financial contribution from SA Water to enable the Council to complete a full road rehabilitation at American River.

Council has engaged Downer EDI Works, a contractor, to fix the section of Redbanks Road between Buick Drive and the end of the bitumen.

Works started on **Friday, 22 March 2024**, and, depending on weather conditions, are due for completion by **Friday, 12 April 2024.**

In the meantime, traffic management and warning signs will be in place. Council will conduct dust suppression until construction on the road begins.

We ask road users to please adhere to posted speed limits and drive safely. We apologise for any inconvenience while this work takes place.

PUBLIC CONSULTATION

The State Government is updating South Australia's bushfire hazard mapping and overlays in the Planning and Design Code. Bushfire hazard area

mapping has been



undertaken for parts of the state where the areas mapped are considered to be higher risk areas, with the application of 'high', 'medium', and 'general' bushfire risk areas.

This updated bushfire hazard mapping will be incorporated into the bushfire hazard overlays of the South Australian Property and Planning Atlas (SAPPA). The draft Code Amendment enables future updates to bushfire risk ratings and hazard mapping without undertaking a Code Amendment process.

Kangaroo Island has been classed as mostly high (in red on the map) and medium (in blue on the map).

It is critical that residents of Kangaroo Island have their say about the planned changes to the Planning and Design code and learn how it will affect future development on KI.
