A Proposed Licence – Airstrips and other Land, Kangaroo Island Airport, 415 - 431 Arranmore Road, Cygnet River

Council's proposed licencing of the Airstrips and other Council's consideration of an application from the Land, Kangaroo Island Airport, 415 - 431 Arranmore Road, Cygnet River, is now open for Public Consultation for a period of 21 days commencing Thursday 22 June 2023 and closing 5:00pm, Wednesday 12 July 2023.

Council is seeing written submissions with respect to the licencing of local government land as follows: LAND- Kangaroo Island Airport, 415 - 431 Arranmore Road, Cygnet River SA 5223, CT 6177/311, Allotment 92, Filed Plan 208026, in the Area named Cygnet River, Hundred of Menzies and CT 6215/983, Allotment 10, Deposited Plan 111910, in the Area named Cygnet River, Hundred of Menzies;

PROPOSED LICENSED AREA- part of the land;

PROPOSED LESSEE- South Australian Country Fire Service (CFS) ABN 97 677 077 835;

PROPOSED TERM- up to 10 years;

PROPOSED USE- The storage of the CFS Property on the Land; carrying out of CFS, firefighting and emergency response training exercises; use of the Airstrips by the Aircraft responding to fires and other emergencies; and other associated activities during fire danger season.

Note: the proposed licence does not grant exclusive use of the airstrips to the CFS. I.e. it does not prevent the use of the airstrips or airport by other authorised users.
