FRIENDLY REMINDER: ROOSTERS IN TOWNSHIPS

Council is receiving numerous complaints about roosters in townships.

Roosters are disruptive and not allowed in townships. Council's Keeping of Livestock, Fowl and Bees By-law states:

"... in the case of a male hatchling, it is not kept on the premises for a period greater than four months or after the point the hatchling reaches sexual maturity and begins to crow (whichever occurs first)."
Please note that non-compliance with this By-law can result in a \$250 fine.
