

# UNSEALED ROAD MAINTENANCE

Council maintains over 1080 km of unsealed roads; this is a large network for such a small rural council to maintain. Grading in the summer months is much more difficult and does not create the best possible outcome due to the lack of moisture in the pavement. Added to this difficulty is the higher usage of our network during summer periods with increased tourism numbers, harvesting and general lifestyle movements. We understand the need for grading during this time and work hard to ensure our roads are kept to the best standard possible throughout these periods.

In the past week 108 kilometres of unsealed roads were graded- this was performed utilising 4 graders at an average of 27 kilometres per day as a combined team. The grading covered 54 kilometres in Newlands District; 32 kilometres in MacGilivray District; 16 kilometres in Wisanger District; and 6 kilometres in the Island Beach Township. In addition to the grading, a significant amount of time was spent clearing drainage pathways along roads as a result of recent flooding rain.

We strive to meet the community expectations and our drivers are all part of the KI community. The next time you pass one of the team give them a friendly wave to show them you appreciate the work they do and the 'dust they swallow' to maintain our roads during summer!

## **SOUTH AUSTRALIAN COUNCIL** RATE REBATE SCHEME

This program aims to support eligible primary producers to assist with farm business related costs.

Rebates of up to 50% (and no more than \$7,500/financial year) of ordinary council rates are available. This rebate applies to ongoing financial commitments associated with South Australian council rate payments.

Applicants may apply for the rebate on a quarterly basis, every six months or on an annual basis. Evidence must be provided that the South Australian local government rates notice has been paid. Applicants will need to re-apply for each financial year. Closes 31 May 2021.

# PROGRESS ON MAJOR PROJECTS

The majority of the shoulder sealing project between Kingscote and Cygnet River has now been completed for the Department of Infrastructure and Transport (DIT) - a project that Council successfully tendered for, and completed in conjunction with 2 major contractors. The scope of work for this project was determined by DIT as this road is under their Care and Control. Council encountered some delays due to mechanical issues but carried out the works with no safety incidents. Edge line road markings will be installed shortly along with sign modifications and a final tidy up of material left over from construction.

The Council road works team have now moved to complete the final stages of the upgrade of Hickmans Road between East West One and East West Two to a new bitumen seal surface. This road will create the north south link from the South Coast to Parndana with the final stage of this project expected to be completed in 2021-22. This is an exciting project and will add another 5km of sealed road to Council's network making for better driving conditions in the Parndana district.

# **TOWN CENTRES PROJECT**

# KANGAROO ISLAND TOWN CENTRES PROJECT

The design process is well and truly underway to improve the main street and foreshore precincts of Kingscote, Penneshaw, Parndana and American River collectively known as the Town Centres Project.

Phase one of these projects is being funded by the State Government's Open Spaces and Places for People Grant and the Federal Government's Drought Communities Programme.

While incorporating feedback from the consultations that were held across the four townships over the past fortnight, Council's Landscape Architect will continue to develop the designs further over the coming weeks.

We're working hard to bring the vision to life to activate and beautify Kangaroo Island's town centres over the next few years, so keep an eye out for further feedback opportunities.

#### TREE DEBRIS

Kangaroo Island Council has been the recipient of over \$600,000 in funding from Green Industries SA (GISA), for the management of dangerous trees on roadsides through the fire scar. GISA identified hazardous trees, branches and limbs along a massive 416 km of sealed and unsealed roads. Council staff managed the engagement process. project delivery and on site management.

This project has treated over 150 trees that were considered by an appointed arborist to be a current or potential danger to motorists and/or farm fences. These trees have been removed and the timber stockpiled in the road verge which may be accessed by the community for firewood if desired. The work commenced in November and will be finalised in the coming weeks.

A subsequent audit of the works by GISA has identified a further 13 trees that present a hazard and other treatments in over 50 locations. This additional work is being summarised and Council is expected to be the recipient of further funding to undertake this extra clean up.
