## PUBLIC CONSULTATION – SARDI Mobile Sheep Blowfly Rearing Facility, Ten Trees Lagoon Road, Kingscote

Council's proposed lease – SARDI Mobile Sheep Blowfly Rearing Facility, Ten Trees Lagoon Road Kingscote, is now open for Public Consultation for a period of 21 days commencing Thursday 29 July 2021 and closing 5:00pm, Wednesday 18 August 2021.

Council is seeking written submissions with respect to the leasing of local government land as follows:

### LAND

Ten Trees Lagoon Road (cnr North Coast Road), Kingscote, SA 5223 (CT5611/656, piece 5, Filed Plan 103561 in the area named Kingscote, Hundred of Menzies)

### PROPOSED LEASED AREA

An area (up to 2 ha) in the north west corner of the identified piece of land with preferred frontage/egress to Ten Trees Lagoon Road. Note: The proposed leased area is an unoccupied section of the land otherwise occupied and known as the "Kangaroo Island Resource Recovery Centre". The final area may be less than 2 ha, subject to development requirements and agreement between the parties;

### PROPOSED USE

Establishment and operation of a mobile sheep blowfly rearing facility and associated activities/consumer services;

### PROPOSED LESSEE

### PROPOSED TERM

2 to 5 years.
