### **PUBLIC CONSULTATION COMMUNITY LAND MANAGEMENT PLAN CONSULTATIONS**

#### What are Community Land Management Plans?

All local government land, except for roads, owned by the Council or under the Council's care and control, including Crown Land, is classified as community land unless the Council has resolved to exclude the land from its community land status.

The Local Government Act 1999 requires the Council to prepare and adopt a Community Land Management Plan (CLMP) for all community land. The plans provide details of the land and outline and proposals for management of the land. Proposals include: how the Council will manage and maintain the land held for the community's use and enjoyment.

Council is currently reviewing several of its CLMPs that require amendment to comply with the Local Government Act 1999 and updating the proposals for land management, including the CLMPS listed below.

The details of the updated CLMPs for public consultation include:

- Details of the land.
- The purpose for which the Council holds the land
- States the Council's objectives, policies and proposals for management of the land
- Outlines Council's performance targets and methods of measuring performance against the stated objectives.

### **AMERICAN RIVER REMEMBRANCE RESERVE** & CAMPING RESERVE

#### **BAUDIN BEACH BOAT RAMP AND FORESHORE RESERVE**





#### **CAPTAIN MORGAN PARK**

Council is seeking written submissions with respect to the proposed amended Community Land Management Plan (CLMP) Data Sheet.



This CLMP outlines changes to the ownership, land description

- Investigate the portion of the land containing the telecommunications tower and helipad being transferred to Council freehold in order to realise Council's equitable interest in the land.
- Alternatively, undertake a land division to separate the Helipad and telecommunications tower from the remainder of the land.
- If land division occurs seek rededication of the land in order to reflect an appropriate purpose for each portion (i.e. Communication and Emergency Purposes and Scenic Area Reserve and Community Purposes).

## **AMERICAN RIVER NORTHERN DAY VISITOR AMENITIES** AND BEACH/FORESHORE




