

## Dauncey Street Traders Open For Business.

Axiom Projects have returned to Kingscote to finalise works on Dauncey Street from Monday 14 November.

Axiom has advised Dauncey Street will be closed for one week from 14 November 2022, re-opened for two weeks and finally closed for two weeks, weather dependent before works is complete next month.

Parking will be made available in the car park behind the Council Chambers on Osmond Street, with temporary 15-minute and parking for people with disabilities near the Murray Street and Commercial Street ends. Long vehicle parking will be available on the hardstand near the old police station on Kingscote Terrace, this includes boats, trailers, campervans, and trailers.

While the road will be closed for general traffic, access will remain for emergency services and deliveries.
