NEW FRUIT RESTRICTIONS FOR THE RIVERLAND

RECEIPTS RULE NO LONGER APPLIES

New regulations have been applied to people travelling into the Riverland from South Australia and interstate. Before 29 July, travellers could bring certain fruitfly vulnerable fruits into the Riverland if they were able to provide receipts to local authorities to verify their origin. However, this is no longer the case.

A blanket ban applies to fruits such as apples, oranges and bananas - fines apply.
